- A. CURRENT STATUS: OPEN SUBMITTED FOR REVIEW
- B. NOTIFICATION: 13 APR 2021 SEA POWER, R21 VHF/FM CHANNEL 16
- NARRATIVE: AT 1628LCL / 2128Z (CORRECTION FROM 1730 LCL), ON APRIL 13, 2021, SECTOR NEW ORLEANS RECEIVED A REPORT OF AN OVERTURNED US FLAGGED LIFT BOAT. THE SEACOR POWER CAPSIZED WITH 19 PERSONS ONBOARD. SCC ENTERED THE DISTRESS PHASE AND ASSUMED SMC (CDR FERGUSON). SCC ISSUED AN UMIB WITHIN 10 MINUTES AT 1640LCL (2140Z). DURING THE INITIAL PHASES OF THE CASE, ALL AIRCRAFT WERE GROUNDED DUE TO INCLEMENT WEATHER (HIGH WINDS, LIGHTENING, POSSIBLE CYCLONES/TORNADOES, LIMITED VISIBILITY, ETC.). STA GI REQUESTED AN OPERATIONAL WAIVER TO GET UNDERWAY, WHICH WAS GRANTED BY CAPT WATSON. SCC CONTINUED LAUNCHING MULTIPLE ASSETS, INCLUDING THE CGC AMBERJACK, WHICH WAS DIVERTED FROM A SEPARATE T.O.W. SAR CASE. THE AMBERJACK REPORTED AN ETA OF 6 ½ - 8 HOURS, HOWEVER, THEY WOULD HAVE ONLY HAD A 12-HOUR WINDOW TO REMAIN ON-SCENE DUE TO WEATHER CONDITIONS AND BEING AT A 50% FUEL STATE. THE AMBERJACK REFUELED, TO MAXIMIZE ON-SCENE TIME ONCE ON-STATION IN ORDER TO TAKE OVER AS OSC WHICH FURTHER PUSHED THEIR ON-SCENE ARRIVAL PROJECTIONS. DUE TO THE NATURE OF THE SITUATION, SCC INITIATED THE ICS SYSTEM AND REQUESTED EMFR TO STAND UP AN INCIDENT MANAGEMENT TEAM. TO SUPPORT WATCHFLOOR SAR EFFORTS SCC RECALLED ALL AVAILABLE OUS AND SUS TO SURGE THE WATCH. THE CGC GLENN HARRIS, A PRE-COMMISSIONED COAST GUARD CUTTER, RESPONDED AS A VESSEL OF OPPORTUNITY AND WAS ON-SCENE WITHIN 34 MINUTES FROM SCC NOLA'S INITIAL REPORT. THEY REPORTED WITNESSING INITIALLY 5 PERSONS, THEN 4, AND FINALLY 3 PERSONS ON THE HULL OF THE SEACOR POWER. THE GLENN HARRIS WAS ASSIGNED AS ON-SCENE COORDINATOR AND RATHER THAN SEARCHING, MAINTAINED STATION WITH THE 3 SURVIVORS REMAINING ON THE SEACOR POWER'S HULL. AFTER THE WEATHER SUBSIDED AIRSTA NOLA, ATC MOBILE, AND AIRSTA CORPUR CHRISTI LAUNCHED. A TOTAL OF 05 SLDMBS WERE INSERTED & SCC CHANGED SEARCH AREA D MULTIPLE SAR ASSETS SEARCHED 9293 SQNM OVER 184 HOURS, EXCEEDING THE PSDA SURVIVAL NUMBER BY 162 HOURS. IAW D8 ACTSUS POLICY SECTOR NOLA, CAPT WATSON, SUSPENDED AS A CONFIRMED PIW. CAPT WATSON, SC, HAD SUSPENSION AUTHORITY AND D8 CONCURRENCE WAS REQUIRED DUE TO PERSONS KNOWN TO BE MISSING. SRUS HAVE THOROUGHLY SATURATED THE SEARCH AREA FOR OVER 184 HOURS AND OVER 9293 SQNM. WE INSERTED A TOTAL OF 05 SLDMBS AND CHANGED OUR SEARCH AREA W/ THAT INFO, AND FOUND NO SURVIVORS. THE PSDA SURVIVAL TIME HAS BEEN EXCEEDED BY OVER 162 HOURS. THE SURVIVORS WERE FOUND AS A RESULT OF THE USCG INITIAL ACTIONS, NO SURVIVORS WERE FOUND DURING CONTINUED SEARCHES. WE RISK SIGNIFICANT FATIGUE TO OUR SRUS AND IMT/SAR PERSONNEL IF WE CONTINUE SEARCHING. CONTINUING SEARCHING WILL NOT SIGNIFICANTLY IMPROVE OUR POS. NOK HAS BEEN BRIEFED. WHEN CG NOLA SUSPENDED THERE WERE 06 RECOVERED SURVIVORS, 07 RECOVERED DECEASED, AND 07 REMAINED MISSING. SALVAGE & MARINE CASUALTY INVESTIGATION LEAD BY MSU HOUMA. CASE SUSPENDED.
